2.0 INTRODUCTION

The meeting started at 12: 53pm with an opening prayer by one of the representatives of Mantrac Nig. Ltd (Mr. Babatunde). The Centre Director welcomed the general public that attended the meeting. He stated that the meeting was called to open the financial bids of the successful bidders, i.e. the contractors who passed the Technical Evaluation stage while the financial bids of those contractors who failed the Technical Evaluation would be returned unopened. He said the objective of the evaluation focused on the documents submitted by the Contractors and the eligibility criteria published in the National dailies.

Based on the above information, the bids of the unsuccessful bidders were returned immediately. However, the Chairman pleaded with them to stay in the room to observe the process of financial bid opening. The representative of Megastructure Tech. Nigeria Ltd. asked why the Sworn Affidavit submitted was not accepted by the Technical Evaluation Committee. The Chairman responded that the Sworn Affidavit was not recent but expired and could not be used to assess the current bid.

In the same vein, the representative of David and Salem Global Limited said that his company was disqualified for non submission of the current year ITF and defended his case that other Institutions accept previous year's ITF simply by showing them evidence that the relevant documents are with ITF for the processing of the current year's certificate. The Chairman responded that the Bureau of Public Procurement charged all Ministries, Departments and Agencies (MDA's) with the responsibility of collection of copies of Certificate issued by Agencies and verification of such Certificates from the appropriate Issuing Agencies, but not the evidence of submission for the processing of Certificates. He explained further that findings from the Agency (ITF) at that time reflected that the company (David and Salem Global Limited) was not eligible for the current year.

3.0 OPENING OF FINANCIAL BIDS

The financial bids were opened lot by lot and read clearly to the general public as stated below:

4.0 OBSERVATIONS

The following were observed during the opening of the bids:

- 1) that Dizengoff West African Company (Nig.) Limited attached photocopies of Bid Security to its bids and claimed that the original copy is in the Technical Bid;
- 2) that Cloverfields Limited attached only one Bid Security to cover all bids applied for;

- 3) in some financial bids, Bid Security were not provided, but the suppliers/contractors claimed that the bids security were enclosed in the Technical Bids;
- 4) one of the external observers particularly the Chairman, Nigerian Society of Engineers said openly that the procedure adopted by the Centre was transparent and bidders displayed high level of competence. In addition, he said that the bidders who applied, but did not submit the bid security should not be reckoned with and not included in the financial bid opening list next time; and
- 5) the representative of Messrs. Mantrac (Nig.) Limited also said that the procedure was transparent.

The Chairman gave words of counsel to the unsuccessful bidders present that they should not lose hope but get their papers ready since the Centre has other projects that would still be advertised in the coming year. He also advised that bidders should get their papers well organized when dealing with issues like this. The superior officers in the company should thoroughly vet the documents their subordinates have packaged for this kind of exercise to ensure that current and recent documents are submitted to enable them qualify for any project being applied for.
