CONTRACT AGREEMENT

This Contract Agreement is made the 8th day of March, 2017

BETWEEN

- (1.) Federal University of Agriculture, Centre of Excellence in Agricultural Development and Sustainable Environment (CEADESE, World Bank Assisted Programme) an Agency of Federal Ministry of Education, Nigeria, incorporated under the Laws of Federal Republic of Nigeria and having its principal place of business at Alabata road, Abeokuta, Ogun State, Nigeria (hereinafter called "the Purchaser"), and
- (2.) Katchey Company Limited a company incorporated under the Laws of Federal Republic of Nigeria and having its principal place of Business at 26, Odanye Close, Off Adeniyi Jones Avenue, Ikeja, Lagos-State, Nigeria. (hereinafter called "the supplier").

WHEREAS the purchaser invited bids for certain goods and ancillary services, viz procurement of **REAGENTS AND SPECIAL RESEARCH CONSUMABLES** and has accepted a bid by the supplier for the supply of those Goods and Services in the Sum of ₦59,518,936.49 (Fifty-Nine Million and Five Hundred and Eighteen Thousand, Nine Hundred and Thirty-Six Naira, Forty-Nine Kobo) only inclusive of VAT. (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


- (3.) In this Agreement words and expressions shall have the same meanings as are respective assigned to them in the Conditions of Contract referred to.
- (4.) The following documents shall constitute the Contract between the Purchaser and the Supplier, and each shall be read and constructed as an integral part of the Contract:
 - (a) This Contract Agreement
 - (b) Special Conditions of Contract
 - (c) General Conditions of Contract
 - (d) Technical Requirements (including Schedule of Requirement and Technical Specifications)


- (e) The Supplier's Bid and original Price Schedules
- (f) The Purchaser' Notification of Award .

- (5.) This Contract shall prevail over all other Contract documents. In the event of any discrepancy or inconsistency within the Contract documents, then the documents shall prevail in the order listed above.
- (6.) In consideration of the payment to be made by the Purchaser to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Purchaser to provide the Goods consideration Services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- (7.) The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the Goods and Services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
