### DISBURSEMENT FOR CEADESE RESULTS ACHIEVED FOR THE PERIOD 2019/ 2020 – DLR 2.1 & 2.2

I bring you warm greetings from the AAU.

As agreed in the Financing Agreement and Minutes of Negotiation for each country participating in the Africa Centers of Excellence project, the results for the ACEs must be verified by the Association of African Universities (AAU). Actual verification was undertaken by third parties on contract from the AAU. Student enrolment and outreach (internships) results were validated by Technopolis through online surveys and telephone calls; Elsevier confirmed research results; Accreditation results were verified by the AAU through examination of the accreditation certificates, reference to relevant information on the websites of the respective accrediting agency and correspondence with the same agency; Externally generated revenue was verified as a component of the centre's annual financial audit; while procurement and financial results were verified by the relevant World Bank teams.

Based on the verification of **DLR 2.1- 2.2**, the **Africa Centre for Agricultural Development and Sustainable Environment (CEADESE)** has achieved results valued at **SDR 103,120**. Please find attached a schedule of the DLRs achieved and the associated earnings so far in the project.

**CEADESE** has further submitted documentation that it's Eligible Expenditure Program for the period in question (February 25, 2015 – date of signing of the Financing Agreement to June 30, 2017) equals **NGN 8,931,681,338.43** equivalent to **SDR 25,448,153.73** of which **SDR 3,166,880.00** has previously been reimbursed for achievement of results in previous years. Therefore, the remaining EEP that potentially could be reimbursed amounts to **SDR 22,281,273.73** which exceeds the amount that the results verified.
