## RESULTS OF THE MARCH 2017 ACCREDITATION OF POSTGRADUATE ACADEMIC PROGRAMMES OF AFRICAN CENTRES OF EXCELLENCE (ACEs) IN NIGERIAN UNIVERSITIES

The National Universities Commission (NUC) has the statutory mandate to accredit academic programmes in all Nigerian Universities. Pursuant to this mandate and in consonance with the provisions of Government approved guidelines, the NUC organized in March 2017, the accreditation of postgraduate academic programmes of African Centres of Excellence (ACEs) at the Federal University of Agriculture, Abeokuta. After due consideration of the exercise, the results of the Masters/Doctorate degree programmes were approved for release.

- a) **Accredited** status is valid for a period of 5 years;


b) **Not Accredited** status attracts the following sanctions:

- i) Immediate ban on student admission into such programmes;
- ii) Certificates issued to students admitted into such programmes after the ban on admission, will not be recognized. (Students currently enrolled on the programme will not be affected).
- iii) The re-visitation to programmes that earned Not Accredited status is strictly on University's request.

Attached are details of the technical report(s) for the programme(s).

It is our hope that as the Vice-Chancellor of Federal University of Agriculture, Abeokuta, you will take necessary steps to facilitate the University to remedy the deficiencies associated with the programmes visited.
